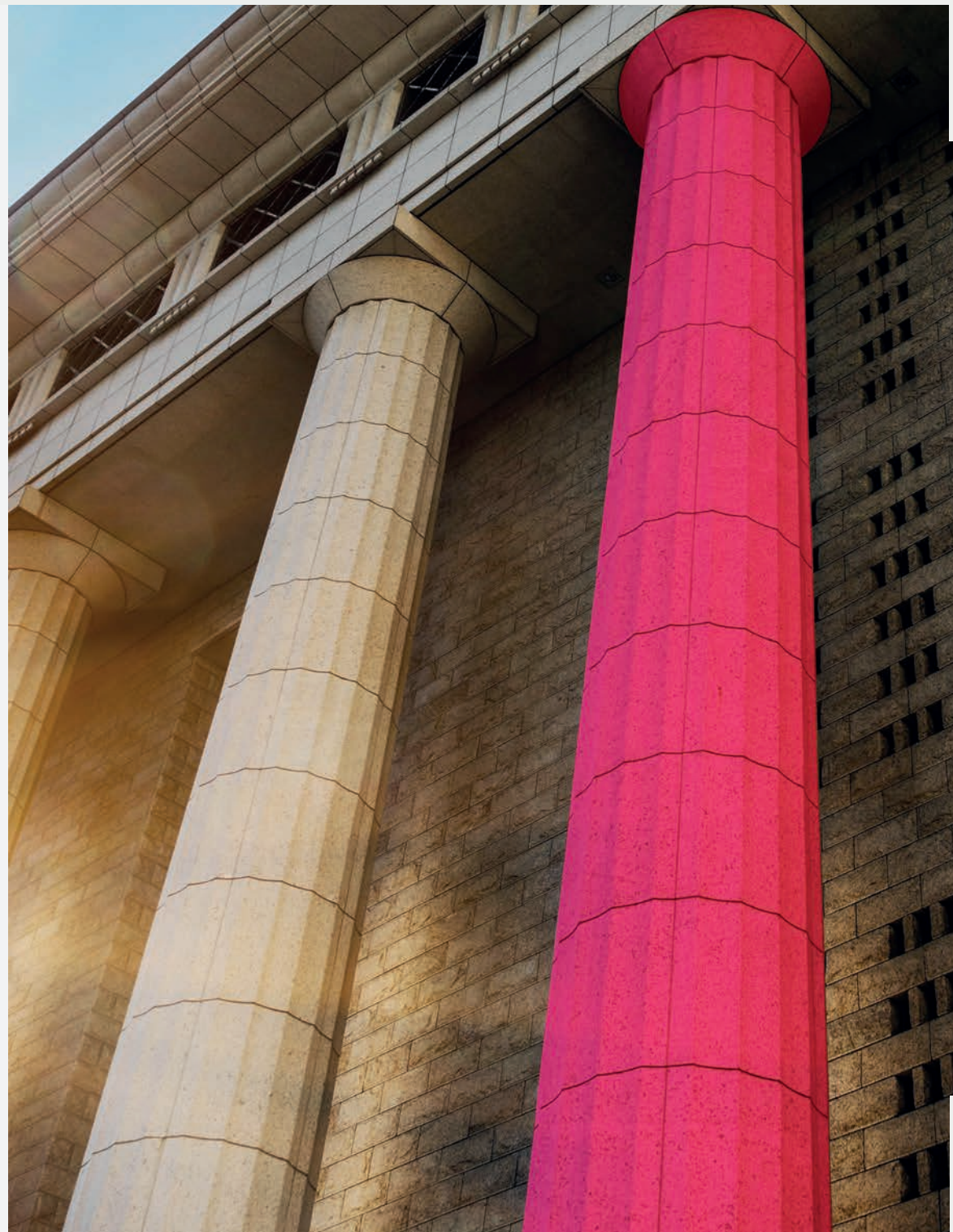

Lendco information

- › **All standard re-finances can proceed on a dual represented** basis meaning Lendco's solicitor acting for us and the borrower. (This is the most cost effective for the borrower seeing they only have one set of fees to pay, and we have one solicitor acting meaning a smoother process. Ideally, we would recommend that customers proceed this way on as many re-finances as possible)
- › All purchase transactions will need to proceed on a sole represented basis, meaning the **customer will have to have their own SRA solicitor acting and Lendco will have one of our panel members act for us**. Please note that solicitors not included on our attached panel list **cannot act for Lendco**
- › Dual representation on re-finances is only available for **loan amounts up to £1 million**. A bespoke quote would need to be obtained from one of our solicitor panels if the intermediary requests dual representation on any loans over this amount. Please email the completions team at completions@lendco.co.uk for any enquires
- › Any complex transactions with multiple units, leases etc. will need to be quoted on a bespoke basis. Again, please email completions@lendco.co.uk if you receive any enquires
- › The solicitor/firm acting on behalf of the borrower **must be SRA regulated**
- › Out title insurance is available for loans up to **£3 million**. Any loans over this will need to proceed with a full title investigation, and if agreed by the underwriter an exception with a no search indemnity policy
- › Multi-unit Freehold block properties can be covered by title insurance at a fee of **£600 for units up to 10**. Any units over 10 units need to be sourced on a bespoke basis
